







6th World Water Forum, Marseille (France), 12th - 17th March 2012 TIME FOR SOLUTIONS

The Role of Local and Regional Authorities

→ Background

Every three years, the World Water Council organises a World Water Forum in close collaboration with the authorities of the host country. These forums are the largest international events related to the water sector and the last forum which was held in Istanbul in 2009 reached 25,000 participants.

A political process was launched by the Local and Regional Authorities at the March 2006 4th World Water Forum in Mexico with the support of the United Cities & Local Governments (ULCG). On this occasion, a high level dialogue was established between local representatives, ministers and parliamentarians. The Declaration which was adopted at the time by the local authorities was incorporated into the Ministerial Declaration.

During the 5th World Water Forum (Istanbul, 2009), the UCLG, the International Council for Local Environmental Initiatives (ICLEI), Local Governments for Sustainability and the World Water Council joined efforts in order to mobilise more than 250 representatives worldwide and convince them to adopt the Istanbul Water Consensus. This Consensus brings together local key players who get involved and seek the best policies and practices within the water and sanitation sector in order to meet global challenges. To this day, more than 900 cities and regions have signed the Istanbul Water Consensus, and we hope to reach 1,000 signatories for the 6th World Water Forum.

As part of the 6th World Water Forum – Solutions Time – which will be held between 12th and 17th March 2012, local and regional authorities will be invited to bear witness of their commitment, share their own solutions to tackle major water-related issues worldwide, and reassert their essential role in improving access to water and sanitation.

\rightarrow Local and Regional Authorities' political process: objectives for the 6th Forum

There are five specific objectives:

- 1. Increase international mobilisation of Local and Regional Authorities (LRAs) within the water sector and encourage them to make commitments, for example by signing the Istanbul Water Consensus;
- 2. Give LRAs the opportunity to engage in a dialogue with experts working in the water and sanitation sector. As a result, they will be able to identify and develop concrete solutions to meet the challenges they are facing;
- 3. Develop and improve the geographical balance of signatories to the Istanbul Water Consensus;
- 4. Encourage new partnerships between LRAs (e.g.: via decentralised cooperation);
- 5. Develop a constructive dialogue between other political levels.

\rightarrow Structure and political content of the Forum

So as to best respond to the global water challenges, the 6th World Water Forum is guided by 12 Priorities for Action and 3 Conditions for Success, translated into common and measurable goals. These targets and their roadmaps provide a strategic frame to the identification and replication of promising solutions.

The political process of the 6th World Forum will include:

- Ten high-level roundtables (behind closed doors) organised by one or several governments: on 13th March (am);
- A Ministerial Conference on 13th March (pm);
- The 3rd International Conference of Local and Regional Authorities for Water: on 14th & 15th March (am & pm);
- Four "regional trialogues" (Africa, Americas, Asia-Pacific and Europe) organised between ministries, parliamentarians and local governments: 14th March (pm);
- A Parliamentary Conference: 15th March (am & pm);
- Commitment Day (declarations and official speeches): 16th March. Local and regional authorities shall express their views in the afternoon.

→ 14th-15th March: 3rd International Conference of Local and Regional Authorities

Over 350 local and regional authorities are expected to attend this conference organised by the World Water Council in partnership with the United Local Cities and Government. Several sessions will be held with a view to:

- Put forward solutions implemented by the LRA to cope with challenges they are facing in the sector of water and sanitation. As part of the Conference, a prize will be awarded to the best solution presented by an elected representative:

- Present the progress achieved by the IWC signatories since the 5th Forum within the following contexts: rural, urban, megalopolis, village.
- Exchange on key issues such as water and urbanisation, cooperation and solidarity or regional governance;
- Develop and foster new partnerships between cities and/or regions through a "Partnerships Fair." An announcement listing new partnerships will be made during the afternoon of Friday 16th March, on the official Commitment Day.

The Forum will take place between 12th and 17th March 2012 in Marseille, France.

The 6th World Water Forum will be held at Chanot Park – "Palais des Congrès et des Expositions" (Congress and Exhibitions Palace) in Marseille. Located in the 8th arrondissement in Marseille's city centre, Chanot Park covers a 170,000 square-meters-area and is only a few minutes away from the beaches and the Old Port.
