The World Water Council currently unites 342 active member organisations from more than 60 countries. They represent the worldrenowned international and intergovernmental institutions, public and private companies, Governments and local authorities, research centres and civil society organisations.

Members are the heart of the Council as they have an important role both in its Governance and in its activities.

Governance

Members constitute the ultimate authority of the World Water Council. Through the General Assembly, they decide and vote on its future orientation, budget and activities. All Council members enjoy the same rights and benefits; in particular each active member holds one vote. Between two General Assemblies, members are represented by 36 Governors, who oversee the general operations of the Council. To ensure a balanced representation of the various stakeholders within the governing body of the Council, members are classified into five different colleges. Each college is guaranteed with a minimum number of four seats on the Board of Governors.

- College 1: Intergovernmental organisations College 2: Government and governmental authorities College 3: Enterprises and facilities College 4: Civil society organisations and water user associations College 5: Professional associations and academic institutions

HOW TO APPLY FOR MEMBERSHIP?

Membership of the World Water Council is open to any organisation with an interest in water issues that accepts the missions and objectives of the World Water Council as defined in its Constitution and By-laws.

To become a member, please follow these steps:

- 1. First download the membership application form from the website or request it from the Headquarters
- Return the original form dully completed and signed along with some additional information on your organisation, such as a brochure or a description of its water-related activities or any other document you may feel is relevant for your application. Forward the information to the WWC Headquarters by fax (+33 4 91 99 41 01), by email (membership@worldwatercouncil.org) or by post.
- 3. The Council Headquarters will send you confirmation of receipt of these documents. Your application will be submitted to our Bureau for review and forwarded to our Board of Governors for approval. In case the information you have supplied is insufficient, the Headquarters will contact you.
- 4. Notification of acceptance will be sent to you following the decision of the Board of Governors, along with the invoice for your membership fees.
- 5. Your organisation will officially become a member of the Council upon payment of your membership fees.

Membership Solidarity Fund

To enable organizations from low-income countries to become Council members and ensure that their voices are heard, membership fees are calculated according to the organisation's annual budget and GDP for governemental organisations.

A Membership Solidarity Fund has been established to offer the possibility for members from low-income countries and with limited resources to have their membership fees partly subsidized through donations from other members.
